Fences and landscaping go together in adding to or detracting from the character of an historic property or district. A good fence with appropriate landscaping can enhance the architecture of a building and character of a neighborhood.

#### SUBMITTAL REQUIREMENTS

The minimum requirements for filing a request for a front yard wall or fence approval are listed below and shall be submitted through the City's Citizen Portal Access website at <a href="https://automation.ontarioca.gov/onlinePermits">https://automation.ontarioca.gov/onlinePermits</a> or in person at the Planning Department located inside Ontario City Hall. Each item below shall be labeled accordingly and when submitted digitally, must be in WORD, PDF or JPEG file format. An application that does not include the following plans and information will not be accepted for processing:

Site plan showing fence and wall location (template attached)

Fence and wall material (photos, brochure)

Architectural Style of Building (ex. Craftsman, Mediterranean) Fence/Wall Design (ex. Split Rail, Picket)

Fence/Wall Material (ex. Wood, Iron, Stone) Fence/Wall Height (maximum of 3' for front yard)


