- 2. The proposed signs are compatible with the style or character of existing improvements on the site and are well-related to each other; and
- 3. Any deviations from the prescribed sign standards are fully consistent with the purposes of the Development Code.

Attach to this application form, a description of all requested deviations, and the reasons supporting each of the above-listed findings. Failure to clearly establish each finding will result in denial of the deviation request.

INTRODUCTION

The intent of this sign criteria is to provide the guidelines necessary to achieve a visually coordinated, balanced and appealing sign environment, harmonious with the architecture of the project, while maintaining provisions for individual graphic expression.

Performance of this sign criteria shall be rigorously enforced and any nonconforming sign shall be removed by the tenant or his sign contractor at their expense, upon demand by the Landlord.

Exceptions to these standards shall not be permitted without approval from the Landlord and will require approval of a modification to the sign program application by the City.


Accordingly, the Landlord will retain full rights of approval for any sign used in the center.

No sign shall be installed without the written Landlord approval and the required City permits.



LANDLORD/TENANT REQUIREMENTS

- 1. Each Tenant shall submit to Landlord for written approval, three (3) copies of the detailed shop drawings of this proposed sign, indicating conformance with the sign criteria herein outlined.
- 2. The Landlord shall determine and approve the availability and position of a Tenant name on any ground sign(s).
- 3. The Tenant shall pay for all signs, related materials and installation fees (including final inspection costs).
- 4. The Tenant shall obtain all necessary permits.
- 5. The Tenant shall be responsible for fulfillment of all requirements of this sign criteria.
- 6. It is the responsibility of the Tenant's sign company to verify all conduit and transformer locations and service access prior to fabrication.
- 7. Should a sign be removed, it is the Tenant's responsibility to pay to patch all holes, paint surface to match the existing color, and restore surface to original condition.





PROHIBITED SIGNS

- A-frame (portable) signs, unless approved as part of a temporary display by the City of Ontario
- Signs that float in the air, such as signs affixed to, or printed on, hot air balloons, helium balloons, or kites, inflated signs, and any other type of aerial sign, except as temporary signs or displays approved as part of a temporary display by the City of Ontario
- Billboards;
- Flashing, blinking, rotating or otherwise animated signs, except barber poles and time/temperature signs.
- Roof signs;
- Searchlights, open flames, or loudspeakers used to call attention to a product, service or property.
- Signs affixed to a vehicle;
- Signs placed on, affixed to, or erected on or over public rights-of-way;
- Signs that emit or generate sound, smoke or similar material;
- Signs that may interfere with, obstruct, confuse or mislead pedestrian or vehicular traffic;
- Signs shall not be placed on a rock, tree, or other natural feature.
- All other signage not specifically mentioned in this Sign Program section shall be prohibited, pursuant to the Prohibited Sign section of the City of Ontario Development Code



TEMPORARY SIGNS

- (a) Temporary signs, banners, flags, and other advertising devices, except floodlights, placed on an occupant's property, subject to the following requirements:
- (1) Not to exceed 50% of the elevation width upon which the sign is located.
- (2) One wall-mounted banner per tenant
- (3) 50 SF per sign face. Max sign height of 3 feet
- (4) Temporary signs may be allowed up to a maximum of thirty (30) days per calendar year;
- (5) No such sign or device shall pose a hazard to the safe movement of traffic and shall not block the visibility of permanent signs on adjoining properties;
- (b) Temporary window and wall signs are allowed including covering a maximum of:
- (1) Windows facing public streets and/or parking lots shall comply with provisions of this Article, limiting window signs, logos, and other displays to a maximum of twenty-five percent (25%) of the window area to allow visibility into the establishment for security purposes;
- (2) Temporary signs shall be limited to a maximum of 3 periods of 30 days per year.



WALL SIGNAGE GUIDELINES

BUILDING A - INDUSTRIAL WAREHOUSE

WALL SIGNS

- Industrial Warehouse Building signs shall meet the Ontario Development Code Sign Regulations
- Individual channel letter text shall make up the primary sign identity for wall signs.
- Channel letters & logos must be installed flat against the wall with the depth of the sign not exceeding twelve (12) inches;
- Wall and/or fascia signs may be located on an exterior building elevation that:
- [i] fronts/faces a public street, or [ii] faces an interior side or rear of a site, and contains a public entrance
- Tenant wall signs may not exceed 75% horizontal width of building length

BUILDING B - RETAIL (AUTOZONE)

WALL SIGNS

- Development less than 8000 SF
- * 1 sign per elevation; 3 max signs; 50 SF per sign * 2 FT max letter height
- * Logos/Icons: 4 FT max height

- * Signs With Multiple Lines of Copy: 2.5 FT for height of all lines.
- Individual channel letter text shall make up the primary sign identity for wall signs.
- Channel letters & logos must be installed flat against the wall with the depth of the sign not exceeding twelve (12) inches;
- Wall and/or fascia signs may be located on an exterior building elevation that:
- [i] fronts/faces a public street, or [ii] faces an interior side or rear of a site, and contains a public entrance
- Tenant wall signs may not exceed 75% horizontal width of building length

BUILDING C - RETAIL/RESTAURANT (WENDY'S)

WALL SIGNS/ DRIVE-THRU RESTAURANT SIGNS

- Development less than 8000 SF
- * 1 sign per elevation; 3 max signs; 25 SF per sign * 2 FT max letter height
- * Logos/Icons: 2.5 FT max height

- * Signs With Multiple Lines of Copy: 2.5 FT for height of all lines.
- Individual channel letter text shall make up the primary sign identity for wall signs.
- Channel letters & logos must be installed flat against the wall with the depth of the sign not exceeding twelve (12) inches;
- Wall and/or fascia signs may be located on an exterior building elevation that:
- [i] fronts/faces a public street, or [ii] faces an interior side or rear of a site, and contains a public entrance
- Tenant wall signs may not exceed 75% horizontal width of building length




1 EAST ELEVATION - FRONT SIDE



BUILDING C - DRIVE-THRU MENU BOARD DETAILS WENDY'S DRIVE-THRU RESTAURANT





MONUMENT SIGNAGE GUIDELINES

- Commercial Center Identification Sign
- One monument sign for each 500 FT (lineal) of street frontage, with a minimum 300 FT spacing between signs 50 SF per sign face.
- 7 FT max height
- Signs shall consist of individual letters/characters affixed to an opaque, matte finished background. The sign background shall not be internally illuminated; only letters/characters shall be internally illuminated.
- Monument signs for centers/complexes shall be limited to the display of the name of the center/complex and the identification of a maximum of 7 tenants within the center/complex.
- No monument sign shall be located within a public right-of-way, and must be wholly located behind the right-of-way line (street property line) for its full height. Furthermore, such signs shall be located a minimum of 10 FT behind the adjacent curb face (public and private streets).
- Monument sign may be internally or externally illuminated, provided that the illumination is not harsh or overly bright.
